SECTION 5 – CONDITIONS OF REGISTRATION

1. The Player is bound by the Rules, Regulations and Policies of the Caulfield Bears Football & Netball Club ('CBFNC'), the Southern Football Netball League ('SFNL') and AFL Victoria ('AFLV').

By signing this Transfer/Registration Form, the Player:

- a) agrees that he or she be bound by the Rules, Regulations and Policies of the CBFNC, the SFNL and AFLV as they are presently constituted and as amended from time to time including the AFLV policy;
- b) acknowledges that he or she may inspect copies of the Rules, Regulations and Policies of the CBFNC, the SFNL or AFLV during normal business hours at the respective offices of those organizations;
- c) acknowledges that his or her failure to adhere to the Rules, Regulations and Policies of either the CBFNC, the SFNL or AFLV may result in him or her having the playing permit withdrawn;
- d) acknowledges that his or her former club can refuse the transfer within the designated time-frame but only if the former club can substantiate that the Player:
 - i. is contracted; and/or
 - ii. is indebted to the Club; and/or
 - iii. is in possession of Club property that needs to be returned; and/or
 - iv. wishes to withdraw their Transfer application. Clubs can only submit this as a reason for refusal where the Player has signed the Player Withdrawal of Transfer Form.
- e) acknowledges that if any of the information that is supplied by Club or Player is inaccurate the League has the power to withdraw the playing permit immediately.
- f) agrees to paying the fees as mentioned in this form as & when required to do so;
- g) agrees to abide by the club's expectations, policies and behaviour standards.

2. Registration of Players Under 18 Years of Age

Where the Player is under 18 years of age, this form must be counter-signed by a parent or guardian of the player. By signing this Transfer/Registration Form the parent or guardian of the player:

- a. hereby acknowledges that he or she has read and explained the contents of this Transfer/Registration Form to the Player; and
- b. declares that the statements made in the Transfer/Registration Form are to the best of his or her knowledge and belief, true and correct.
- c. agrees to all conditions of this Player Registration/Transfer Form.

SECTION 6 – MEMBERSHIP FEES & MATCH SUBSCRIPTION FEES

To field 2 teams per year, the Club is required to pay for football equipment, SFNL affiliation fees, insurance, umpires fees, ground rental charges, coaching/playing personnel, medical supplies and staff, etc. These costs amount to approx. \$90,000 pa, which equates to approximately \$1,500 per player per season.

In 2019, we expect to raise approx. \$25,000 in Player Membership Fees & Match Subscription Fees for the coming season and will raise the difference between the actual cost (\$90,000) and the Player Membership Fees and Match Subscription Fees (\$25,000) via various fundraising activities (such as canteen/bar sales, raffles, sponsorship, merchandise sales, etc) and we expect players to support these fundraising activities wherever & whenever possible.

For Season 2019, each player will be required to pay:

- **the Player Membership Fee of \$100 (incl. GST) per player – this amount is payable at the time of registration; and**
- **the Match Subscription Fee of \$25 (incl. GST) per match – this amount is payable on the day of the match.**

Payment of these fees can be made by cash or credit card.

SECTION 7 – PRIVACY

The Caulfield Bears Football & Netball Club (CBFNC) will collect, store & use this personal information so it may provide limited medical assistance to the player should an injury be sustained and, for whatever reason, it may need to know this information or relay this information onto another party so appropriate medical assistance can be provided.

CBNFC will, at all times, observe the confidential nature of the information provided however, if needed, it will disclose this information to another organisation(s) or person(s) where it believes it is necessary to assist in the provision of medical assistance to the player.

CBNFC will, at all times, use its best endeavours to obtain your consent or the consent of the person(s) nominated as the Emergency Contact (as stated previously in this document) before disclosing this information however if it is not possible or reasonably practical that such consent be obtained, it may disclose this personal information to another organisation(s) or person(s) without such consent. This information will only be conveyed to another party in an emergency situation.

By signing this document, the player agrees to:

- the collection, storage and use of your personal information;
- a photographic image of you to be posted on the club's website &/or other publication &/or social medium produced &/or managed by the club;
- receive communications and special offers that may include tickets to matches, membership notifications and other promotions from time to time in accordance with the Australian Football Policy available at <http://www.aflcommunity.com.au/privacy>.

SECTION 8 – STATEMENT & DECLARATION

I understand the club will make its best efforts to contact a person nominated as an Emergency Contact on this registration form but if these attempts are unsuccessful I further understand a decision may be made by a duly-qualified sports trainer &/or official of the club to arrange my transfer to another medical facility.

I agree to pay the costs associated with any medical treatment for injuries &/or illnesses sustained by me in participating in the sport of Australian football (including training and socialising) and will not expect any financial assistance from the club in meeting these costs.

I further agree to pay all costs associated with my transfer to another medical facility (such as but not limited to ambulance fees).

I understand the club has an insurance cover that will provide a basic level of protection for its players, volunteers & officials and I accept it is my responsibility to arrange insurance covers such as but not limited to private health insurance & income protection insurance to meet my personal requirements. I do not expect the club to arrange these insurance covers on my behalf nor do I expect the club to meet any out-of-pocket expenses incurred by me as a result of an injury or illness sustained whilst playing or training or socializing in the club's activities.

I agree to pay the Player Membership Fees and Match Subscription Fees and any other monies owed by me to the club and to do so within the required timelines as determined by the club and stated in this form. If the club agrees to accept any or all payments of monies from me in periodical payments, I agree to comply with the terms of such payment arrangement(s).

I agree to pay all outstanding monies (if applicable) owed by me within the timelines agreed with the club and me.
